This state-of-the-art plant, producing models like the Land Rover Discovery and Defender, underscores Slovakia's growing role in global automobile manufacturing. I appreciate President Pellegrini's valuable contribution in facilitating this investment, which has further deepened our economic partnership.

Beyond the automotive industry, many other Indian companies established a presence in Slovakia, many of whom are represented here today. Similarly, several Slovak firms are actively participating in India's industrial growth. These collaborations highlight the growing depth of our economic engagement.

In today's world of uncertainties, India stands out as a shining example of progress, due to its stable political environment and reform-oriented economic agenda, which encourages manufacturing sector, and promotes 'Ease of Business'.
